

Albuquerque Dove Release

Terms of Agreement and Dove Release Contract for Weddings

Fees

In order for the client to reserve a dove release from Albuquerque Dove Release (ADR) for a wedding, a non-refundable fee of twenty-five dollars (\$25.00) is required to secure the date and time of the dove release. The remainder of the balance is due four (4) weeks before the wedding.

Cancellation and Refund Policy

If the client wishes to cancel the dove release, he or she must do so two (2) weeks before the wedding to receive a refund, less the \$25.00 non-refundable fee. Refunds will be mailed within 30 days of the contracted event.

ADR reserves the right to cancel the dove release in the event of bad weather that might inhibit a safe return flight of the doves. If ADR determines that weather conditions are not favorable for a safe release of the doves, a full refund, less the \$25.00 non-refundable fee, will be made by ADR to the client(s). These weather conditions may include, but are not limited to rain, thunderstorms, strong winds, extreme heat or cold, fog and snow. During such conditions, birds cannot be released. Albuquerque Dove Release determines whether dove releases must be cancelled due to inclement weather.

If the weather forecast predicts possible bad weather, the client may request that ADR still attend the event. However, if after attending the event, ADR sees the conditions to be unfavorable for a safe return flight, ADR reserves the right to cancel the dove release and retain all fees paid.

ADR reserves the right to cancel a dove release due to dangers to the doves not previously disclosed to ADR. If the danger to the doves is due to the client(s) or their guests, ADR reserves the right to retain all fees paid. If the danger was unforeseen or due to acts of God, ADR will refund all fees paid, less the \$25.00 non-refundable fee.

If the client(s) cancel the wedding ceremony or delay the dove release for more than 45 minutes, ADR reserves the right to cancel the dove release and retain the fees paid.

ADR, at its sole discretion, may cancel a release. Events that may lead to a cancellation include, but are not limited to, inclement weather, release delays, Acts of God, accidents resulting in loss of stock, stock flight worthiness, or inability of staff to appear at release site.

In the unlikely event that ADR loses its flock of doves due to sickness, unforeseen acts of God, or vandalism, ADR will notify the client(s) and refund all fees paid.

Dove Release Policy

ADR believes its doves are safe to handle and fly. However, ADR releases live doves which fly wherever they want when released. ADR is not liable for any damage or injuries caused by the doves. ADR is not liable for damages due to cancellation of a dove release. ADR will check the release site to ensure adequate open air space with no obstacles before authorizing the release.

All doves must be released from ADR-supplied baskets or at the discretion of the release specialist.

The dove release must be done before the release of any balloons, rice, birdseed, confetti, or anything else into the vicinity of the ceremony. This requirement is to ensure that the birds have an opportunity for a clean release, free from any foreign objects obstructing the airway.

Media Created by ADR

The client(s) gives permission to ADR to display any photographs or video footage taken of the dove release on the ADR website and ADR promotional materials. All photographs taken by ADR will belong to ADR.

Your signature indicates that you have read and agree with the terms set forth within this agreement above.

Albuquerque Dove Release Contract

This contract is an agreement between the client(s) and ADR pertaining to the dove release.

Albuquerque Dove Release is committed to making dove releases a memorable event for all occasions. We guarantee our releases are coordinated by knowledgeable staff.

- We only release well trained birds outdoors during daylight hours at distances that they can safely return to their loft before sunset.
- We arrive at the release site 30 minutes prior to the time of the event to begin our set up. It is highly recommended you include ADR in your rehearsal ceremony so we can develop a release plan prior to your big event.
- We dress in appropriate clothing for the event.
- The safety and well-being of our birds must be considered and preserved at all times.
- We do not ship birds for self-release.

A non-refundable fee of twenty-five dollars (\$25) is required to secure the date and time of the dove release. The remaining balance is to be paid in full four (4) weeks prior to the release date.
